- ∞ A non-refundable \$21.40 (inclusive of GST) registration fee must accompany every new application.

- ∞ A withdrawal notice should be submitted with due consideration. Once submitted, the student will be withdrawn from class and has to reapply for the next registration cycle if he/she seeks to return to the programme. A registration fee of \$21.40 will apply for the new registration.

- Please note that a minimum of 5 students is needed to start a class. Students registered for classes with less than 5 students will be placed on a waiting list.
